 - a) South Yorkshire Bus Review Consultation Resolution 19

It was reported that, as part of the Bus Service Review in South Yorkshire commissioned by the Mayor of South Yorkshire, a consultation session for Blaxton and Finningley residents would be held. The event would be publicised when arrangements had been finalised.

The Chair reported that he been invited to meet Nick Fletcher, the MP for Don Valley Ward, to provide background information on the issues identified by the Parish Council which affected Blaxton residents.

- Traffic speed (30mph needed) and volume on all approaches to Blaxton Roundabout

- Bank End Road traffic speed, volume, width of carriageway near 'The Hollies' and maintenance of (sunken) drain covers.
- Flawed traffic impact assessment process for major developments because each application is viewed in isolation on values produced by the Developer's contractor and, DMBC have no current baseline road traffic statistics to aid their judgements. The roads may be able to take the volume but, no consideration is given to the impact on local residents when going about their normal business.

7) DMBC AND EAST AREA COMMUNITIES TEAM ISSUES

a) <u>HGV traffic, operation times and speed of vehicles on Bank End Road – Resolution 2</u> <u>Traffic Count</u>

Ward Councillor R A Jones attended the meeting and presented extensive information about traffic numbers, vehicle types and vehicle speed on Bank End Road. The data was collected from 1 to 12 November 2019 from a collection point just within the 40mph speed limit.

Councillor Jones also explained that he was concerned about the noise impact of vehicles travelling over sunken grates and the width reduction caused by the erosion of the grass verge on the south side of Bank End Road.
