f) Public Space Protection Order (PSPO) Dog Fouling & Control Consultation – Council was requested to consider the proposal to renew the Public Space Protection Order (PSPO) Dog Fouling & Control – circulated 20/09/22.

That the Council respond with the following two suggestions on the proposed renewal of the Dog fouling and Dog control Public Spaces Protection Order;

<u>"Leads must be worn:</u> 3. All sports grounds, fields, parks and pitches, which are maintained by the local authority and are not subject to 'Dog Exclusion', but only when in use for officiated sporting matches" – That the addition of 'Organised Sports Training' be included and that a further requirement when 'Leads must be worn' be included when there is doubt in a dog's temperament/behaviour in the presence of other people and/or other dogs in a public area.

g) Remembrance Service

Quotations had been requested from three Companies for the traffic management of the Remembrance Service on 13 November 2022. Two options were to be considered; Option 1 – Bank End Road closure for the duration of the Service at the War Memorial only; Option 2 – Bank End Road closure for the duration of the Service at the War Memorial plus rolling road closures/traffic management for a Parade down Station Road on to St Oswald's Church, Finningley.

Quotations for both options were received from two of the Companies and Council was requested to consider these.

RESOLVED (9)

That the Council accept the quotation for Option 1 from Chevron Traffic Management Ltd for £945 excl VAT and the Clerk contact all parties involved to provide an update.

h) Park Lane

Councillor Scutt reported on the issues residents of Park Lane were experiencing;

- i) <u>Speed bumps</u> there had been reports of speeding along Park Lane and a resident had installed a speed bump as a preventative measure. However, it was reported that a Council Officer had visited to request the speed bump be removed.
- ii) <u>Fencing</u> there was still concern that the fence installed at the rear of 15 Hillscroft Road was over the boundary onto Park Lane and no progress had been made with queries raised with DMBC Planning and Highways departments.

That the Clerk be requested to make further enquiries to find out who would be able to assist with the above issues.

i) Plant/Floral Displays around the Village

Following suggestions for improving the appearance and visibility of Blaxton roundabout at the meeting with the Local Landscape Garden Designer on 21/07/22, the Clerk had contacted DMBC to seek advice on permissions and was awaiting a date for a site visit with one of the Highways Officers.

11) PLANNING APPLICATIONS

a) Planning Application 22/01290/COU — Change of use from residential home (c3) to children's home for a maximum of 4 children (c2) — Bankswood, Thorne Road, Blaxton, DN9 3AX — 02/08/22 — Clerk's delegated powers 'Objection' for the following reasons;

"Blaxton Parish Council objects to this application for a number of reasons: In our opinion the placement of a children's home of this nature, in this location, is not in keeping with the surrounding properties There are contradictory statements within the application about the number of vehicles that will need access to or park on site. One plan shows 10, the narrative indicates 4. Creating the number of parking areas will reduce or eliminate "open space" around the property. Children need open space. Access to and from the property is onto an unlit 60mph busy road. Possible overspill parking would be dangerous. The rear of the property is countryside, the front a main road. We are concerned, as indicated in the SY Police response, that if any of the children were to abscond, finding them might be difficult, time-consuming or place them in danger. We also agree with many of the statements made in the objection posted by a local resident In summary, it is our opinion that this is not the right location for this type of support for children".
