i) <u>Tree Planting</u>

It was reported that new trees had recently been planted along Station Road and that the Clerk had requested details of this project from DMBC. An officer from the Tree Team confirmed that the tree planting had been funded from a Doncaster Council capital bid and that the trees were all flowering trees; a variety of Japanese flowering cherry, flowering pear (non-fruiting) and crab apple. The officer also advised that they were keen to do more planting in the area and would welcome input into suitable locations on Council land.
